All Southeastern Swimming Clubs must do all athlete registration and all meet entry by Third Party Vendors (ie Hy-tek) by September 1, 2006. All new clubs which join the LSC will receive these programs at a 50% discount. Any clubs that have joined the LSC in the past three years (2002-05) that have not obtained these programs will also receive these programs at a 25% discount rate.
