Format:	<ul> <li>Pre-seeded</li> <li>Timed finals in Long course meters (LCM)</li> <li>All events will be seeded by time and gender without regard to age</li> <li>Except for the 800 and 1500-meter Freestyles, all events will be pre-seeded swum <u>slowest to fastest</u></li> <li>The 800 and 1500-meter Freestyles will require positive check-ins not later than 9:30 AM on the day of the event</li> <li>These events will be seeded on deck and swum <u>fastest to slowest</u></li> <li>Swimmers must be <u>currently</u> (2012) registered with USA Swimming or FINA</li> <li>Entries received without a valid and accurate 2012 USA Swimming Identification Number will not be accepted and any entry fees not refunded</li> <li>No relays</li> <li>No time trials</li> </ul>
Cell Phone Restrictions:	<ul> <li>The presence or use of cell phones, smart phones or any other devices capable of producing audio recordings, photographic or video images in locker rooms, restrooms or changing areas is strictly and specifically prohibited at all times.</li> <li>There are no exceptions to this policy.</li> </ul>

Photographs And Videos:	<ul> <li>There may be one or more photographers and / or videographers on deck at this meet.</li> <li>In the event such personnel are present, parents or guardians of swimmers under the age of 18 who do not wish to have photos or videos of their athletes made, are required to contact the Meet Director prior to the beginning of warm-ups.</li> <li>Photographers and videographers are strongly encouraged to stay out of the area immediately behind the starting blocks, but if present, are specifically prohibited from making shots during the start phase of any race.</li> </ul>
Entry Restrictions:	<ul> <li>This meet is open to <u>all</u> currently (2012) registered USA Swimming and FINA athletes ages 12 and under as of July 7th, 2012</li> <li>Swimmers <u>must</u> enter with a seed time in <u>long course meters</u> (LCM)</li> <li>Swimmers entering with non-conforming times (SCY or SCM) will be seeded last</li> <li>Entries received with No Time (NT) will not be accepted and any entry fees will not be refunded</li> <li>Estimated times are acceptable and desirable for proper seeding</li> <li>Swimmers may enter a <u>maximum</u> of five (5) events per day</li> <li>Entries will be capped at 350</li> </ul>
USA Swimming Registration:	<ul> <li>All swimmers, coaches, and officials participating in this competition must be <u>currently</u> (2012) registered with USA Swimming or FINA</li> <li>All should also be prepared to present their USA Swimming ID Card as proof of their Registration to the Meet Director or designee at any time</li> <li>Swimmers who: 1) chose to enter time trials, if offered, 2) late enter when possible, or 3) need to be late entered because of clerical errors by the entering team and / or the meet host; will be required to present their USA Swimming ID Card</li> <li>South Texas Swimming does not allow on-deck USA Swimming Registrations</li> <li>National and LSC Regulations do not allow for any exceptions to these policies</li> </ul>
Qualifying Times:	■None!
Unaccompani Swimmers:	<ul> <li>aAny swimmer entered in this meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water</li> <li>When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement</li> </ul>

Entry Procedures	<ul> <li>The <u>only</u> acceptable mode of entry is via Hy-Tek Commlink File</li> <li>A hard copy and Entry Fee Report must be included with entries</li> <li>If you have questions on this procedure contact Adrian Montoya at the e-mail address noted below</li> <li>An "HYV" File for Team Manager is available on the Meet Calendar Page of the AAAA Web Site (<u>www.aaaa-sa.org</u>)</li> <li>Entries received without a seedtime (NT) <u>will not</u> be entered into this pre-seeded meet and any entry fees <u>will not</u> be refunded</li> <li>Please be certain to confirm your acceptance into this meet prior to making air and / or hotel reservations</li> </ul>

## **Safety Guidelines and Warm-up Procedures**

#### A. WARM-UP PROCEDURES

I. Assigned warm-up Procedures.

- a. Warm-up lanes and times will be assigned to competing teams based on number of entrants.
- b. All warm-up activities will be coordinated by the coach(es) supervising that lane
- c. Dive sprints may be done only under the direct supervision of the coach
- II. Open warm-up procedures.

#### LANE USE

POOL	PUSH/PACE	DIVES/SPRINTS	GENERAL WARMUP	
8 Lanes	1 and 8	2 and 7	3 through 6	
6 Lanes	1 and 6	2 and 5	3 and 4	

- a. The first  $\frac{1}{2}$  of the assigned warm-up time shall be general warm-up for all lanes.
- b. Push/Pace Lanes will push off one or two lengths from starting end.
- c. Sprint lanes are for diving from blocks or for backstroke starts in specified lanes at designated times one way only!
- d. Dive sprints may only be done under the direct supervision of the coach.
- e. There will be no diving in the general warm-up lanes circle swimming only.
- f. No kick boards, pull buoys, or hand paddles may be used.

#### III. Safety Guidelines

- a. Coaches are responsible for the following:
  - 1. Instructing swimmers regarding safety guidelines and warm-up procedures as they apply to conduct at meets and practices
  - 2. Actively supervising their swimmers throughout the warm-up sessions, at meets, and all practices.
  - 3. Maintaining as much contact with their swimmers AS POSSIBLE, both verbal and visual, throughout the warm-up period.
- b. The host team will be responsible for the following.
  - 1. A minimum of four (4) marshals who report to and receive instructions from the Meet Referee and/or Director shall be on deck during the entire warm-up session(s).
  - 2. Marshals must be members of United States Swimming.
  - 3. Marshals will have authority to remove from the deck for the remainder of a warm-up session, any swimmer or coach found to be in violation of these Procedures.
  - 4 The host team shall provide signs for each lane at both ends of the pool, indicating their designated use during warm-ups.
  - 5 Warm-up times and lane assignments will be published in the meet information and posted at several locations around the pool area and the following statement will appear in the meet information: "South Texas Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet."
  - 6 An announcer will be on duty for the entire warm-up session to announce lane and/or time changes and to assist with the conduct of the warm-up.
  - 7 Hazards in locker rooms, on deck, or areas used by coaches, swimmers, or officials will be either removed or clearly marked.

#### **B. MISCELLANEOUS NOTES**

- I. Backstrokers will ensure that they are not starting at the same time as a swimmer on the blocks. Swimmers shall not step up on the blocks if there is a backstroker waiting to start.
- II. Swimmers shall not jump or dive into the pool to stop another swimmer on a recalled start.
- III. Swimmers are required to exit the pool on completion of their warm-up to allow other swimmers adequate warm-up time. The pool is not for visiting or playing during the warm-up session.
- IV. Warm-up procedures will be enforced for any breaks scheduled during the competition.
- VI. No hand paddles, fins, or kickboards may be used at any time during general, specific, or between warmups unless approved by the Referee.

NOTE: Host Clubs, with the consent of the Meet Referee, may modify the time schedule or recommended lane assignments depending on pool configuration, number of swimmers, or other considerations; so long as safety considerations are not compromised. Any such changes will be announced and/or prominently posted in the pool area.
