SUBJECT: WATER POLO REFEREE SELECTION AND NOMINATIONS FOR 2014

TO ALL UANA MEMBER FEDERATIONS,

We have the pleasure to forward you this correspondence concerning the ***UANA WATER POLO REFEREES LIST 2014***.

Please be advised that each UANA National Federation is entitled to nominate up to fifteen (15) referees to the UANA Water Polo Referees List. Any referee that appears on a particular Federation's FINA Water Polo Referees List for 2014 **may or may not** be included on that Federation's 2014 UANA Referee List but must be identified as a FINA LIST Referee. Please note that we encourage the inclusion of you federations FINA List referees on this list, but it is not required. However, please be advised that only those Federation's FINA List Referees are eligible for selection to officiate at UANA hosted Senior Events, (ie, WC Qualification, Pan American Games, etc.)

You will be able to identify your FINA List Referees on the Nomination Form as well as the FINA Referee School they attended.

Please note that all referees nominated to the FINA Water Polo Referees List from any Federation must have attended and successfully completed an edition of the FINA School for Water Polo Referees during the previous two (2) years.

We hope to establish a similar school requirement for all UANA List Referees in the near future and will keep you informed as to that process. Also, please be advised that any referees that are nominated in addition to a specific Federation's FINA LIST Referees MUST have the approval and sanction of their Federation's General Secretary, their Director of Officials, and/or a member of the UANA TWPC.
