FACILITY:	 Indoor 50-meter pool offers two 25-yard competition pools. 7' deep at the shallow end and 17'1" deep at the deep end; the pool has overflow gutters; non-turbulent lane markers; and Paddock starting blocks with backstroke handles and foot wedges. Colorado Timing System will be used.
	 Colorado Timing System will be used. The Meet Director reserves the right to seed the sessions up to 10-lanes for competition.
	 Sessions will be run in the 25-yd competition pool set up in the shallow end. The deep end of the pool will have a maximum of 14-lanes for continuous warm-up and cool down. A marshal or coach will be stationed by the continuous warmup and warm down lanes to ensure that proper social distancing measures are being taken by the athletes.
	• The competition course has been certified in accordance with current USA Swimming Rules and Regulations, Article 104.2.2C (4) The copy of the certification is on file with USA Swimming.

ELIGIBILITY:	 Open to all athletes on VT, PRVT and their respective unattached athletes who are registered with USA Swimming before the first day of the meet.
	Age on October 24, 2020 will determine age for the entire meet.
DISABILITY SWIMMERS:	 Athletes with a disability are welcome and shall provide advance notice of desired accommodations to the Meet Director.
	• The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	All events will be timed finals.
WARM-UP:	Warmup starts at 7:00am, competition starts at 8:15am.
ENTRIES:	DEADLINE FOR THE RECEIPT OF ENTRIES IS Friday, October 24, 2020
	• Swimmers may enter a maximum of <i>3 individual events</i> .
	• Entries will be processed in the order received and <u>accepted to</u> the greatest extent possible without exceeding the 4-hour/session timeline limit or the limits as mandated by current Commonwealth of Virginia guidelines.
	No deck entries will be accepted.
FEES:	Individual events: \$0.00 Swimmer surcharge: \$0.00
SEEDING:	• Swimmers will report behind the blocks only after the event proceeding them is in the water.
	All events will be pre-seeded.
AWARDS:	No awards will be given.
PENALTIES:	• A fine of up to \$100 per event may be assessed for any illegal participation in the meet. Illegal participation is defined as
	 Entries using fraudulent or non-verifiable times.
	 Athlete competed in the incorrect age group.
	 Athlete is not registered with USA Swimming prior to the first day of the meet.
	• If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.
RULES:	 Any event in which an athlete participated illegally will be rescored and re-awarded. Athletes should arrive in their suits. Locker rooms will not be available.
	 All individuals entering the facility will be expected to answer Virginia Department of Health screening questions to include temperature screening.
	Coaches, officials, and spectators must wear masks.
	• The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Protection Policy will govern this meet.
	• All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
	• Any swimmer entered in the meet must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
	• Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USA Swimming approval.
	 Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>.
	• Changing, in whole or in part, into or out of swimsuit when wearing just one suit in an area other than in a locker room, bathroom, or other space designated for changing is PROHIBITED.
	• An athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The

	athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider.
	• In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area.

	• Timer lane assignments will be announced during the timers meeting - 1 timer will be required
	per lane.

Smoking is NOT permitted within the Town of Christiansburg Aquatic Center. The Town of Christiansburg Aquatic Center is not responsible for any lost or stolen items. Make sure someone you know is always present supervising individual/team belongings. No unauthorized persons are permitted to use the stereo system without the permission of the Aquatic Director. No glass containers of any kind are to be brought into the pool complex. Parking violators will be subject to fines and/or towing as posted. Overflow parking may be pre-arranged with Kroger or Christiansburg High School on weekends. The Aquatic Center strongly encourages showering prior to entering the pool. All emergency exits and walkways must remain clear.
