We will be using 3 stopwatches for this meet.• The competition course has not been certified in accordance with current <i>USA Swimming Rules and Regulations</i>, Article 104.2.2C (4).

ELIGIBILITY:	<ul style="list-style-type: none">• Open to all athletes 8 years old and younger from CVAC, ECAT, ODAC, CGBD, WAC and TIDE registered prior to the first day of the meet.• No on deck Virginia Swimming athlete registration will be permitted.• Age on October 2, 2021 will determine age for the entire meet.

DISABILITY SWIMMERS:	<ul style="list-style-type: none"> • Athletes with a disability are welcome and shall provide advance notice of desired accommodations to the Meet Director. • The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
FORMAT:	<ul style="list-style-type: none"> • Events will be swum in two sessions. TIDE, WAC and CVAC will be in session one. ODAC, CGBD and ECAT will be in session two. • All events will be timed finals.
WARM-UP:	<ul style="list-style-type: none"> • First Session: Warmups start at 7:00 am; competition starts at 7:40 am. • Second Session warmups start at 10:10am; competition starts at 10:50am. • Each team will be assigned a 15 min warmup.
ENTRIES:	<p>DEADLINE FOR THE RECEIPT OF ENTRIES IS WEDNESDAY, Sept 22, 2021</p> <ul style="list-style-type: none"> • Entries must be submitted in short course meters times using Commlink-2 software- • Teams submit entries via e-mail. • A printout of entries must be included or the meet checklist/summary sheet with the name of the person to contact in case of questions must accompany the entries, regardless of how they are submitted. • No Time (NT) and Coach Times (CT) will be accepted for events in which a swimmer does not have a time of record. All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition. • Swimmers may enter a maximum of <i>5 individual events</i> per day. • Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4-hour/session timeline limit.
ENTRIES:	<ul style="list-style-type: none"> • The Meet Director reserves the right to limit entries in any events, if necessary, to prevent too lengthy a session. This may include combining heats and events, which may require reseeding. • Email entries to: stevebialorucki@swimodac.com • Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. No additional heats will be added. Deck entries must be submitted to the Administrative Official on the provided forms.

AWARDS:	<ul style="list-style-type: none"> • Individual events: Ribbons will be awarded for first through sixth place in each event. • Awards will be given for each age group: 6 and under, 7 year olds and 8 year olds.
SEEDING:	<ul style="list-style-type: none"> • All events will be pre-seeded. • Swimmers will be staged by heat assignment.

PENALTIES:	<p>A fine of up to \$100 per event may be assessed for any illegal participation in the meet. Illegal participation is defined as</p> <ul style="list-style-type: none"> • Entries using fraudulent or non-verifiable times. • Athlete competed in the incorrect age group. • Athlete is not registered with USA Swimming prior to the first day of the meet. • If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer. • Any event in which an athlete participated illegally will be rescored and re-awarded.
RULES:	<ul style="list-style-type: none"> • All individuals entering the facility will be expected to answer Virginia Department of Health screening questions. • Athletes must arrive in their RACING suits. Restroom facilities are for EMERGENCY USE ONLY for all. Disinfecting products will be available at the sink area and must be used on any touched surface by each user. • Coaches, officials and spectators must wear masks at all times. • Athletes and parents will enter through the gate by the Guard Shack and exit through the gate by the Clubhouse. The entrance and the exit will clearly be marked. • Athletes and families are to maintain proper social distancing. Participants and family members not adhering to this standard will be asked to leave the premises immediately. • Competition/pool deck will be open to 1 athlete's parent/guardian per swimmer during their child's race. NO siblings will be admitted on the pool deck. NO parents on deck during warmups. • The current USA Swimming Rules and Regulations, including the Minor Athlete Abuse Protection Policy, will govern this meet. • All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. • Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, the swimmer or the swimmer's legal guardian is responsible for ensuring compliance with this requirement. • Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USA Swimming approval • The overhead start procedure will not be used for this meet. • Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u> • Changing, in whole or in part, into or out of swimsuit when wearing just one suit in an area other than in a locker room, bathroom, or other space designated for changing is PROHIBITED. • In accordance with VSI best practices, all swimmers should shower before entering the pool. • Any athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider. • In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area.
