Annual Registration Renewal \$56.00
*(If not completed by the designated due date(s), a late fee of \$25 may be assessed, and the swimmer **WILL NOT** be allowed in the water.)*

⁽¹⁾ The USA Swimming registration portion of the new-swimmer registration fee shall be refundable upon written request to the treasurer, for a period of two weeks from the signing of the registration agreement.

3. ESCROW ACCOUNT:

Payments to the Swimmer's escrow account are required from time to time. These payments are for expenses paid by VSC on behalf of a Swimmer, including meet entry fees, suit orders, t-shirt orders, travel charges, equipment, and any other items that were ordered by the swimmer or the parent.

Your total monthly bill is due by the 15th of each month. If the Swimmer swims one or more days during a month, that month's dues are payable in full. Please notify the Membership Coordinator or Treasurer upon withdrawal from the program. Late fees as outlined in the registration agreement may apply if payments are not received by the 20th of the month.
