Deck entries will be at the Meet Director's discretion, and will only be allowed if there are open lanes available. All deck entries are \$6.00 per individual event and \$15.00 per relay. Payment due upon submission of deck entry.

RULES: Official 2018 Short Course USA-S Rules shall prevail for the meet. Swimmers are not required to be registered USA-S swimmers. Both USA Swimming and YMCA athletes are welcome and encouraged to participate in the meet, but only athletes currently registered with USA Swimming will have times that count in the SWIMS database. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is "prohibited."

In accordance with the Federal Video Voyeurism Prevention Act of 2004 - the use of camera phones or video recording devices in the locker rooms is prohibited.

MEET FORMAT: The meet will be timed final events with the exception of the Open 50 Fly. A prelim for the Open 50 Fly will be held on Friday PM. The Top 8 finishers will swim an Australian Skin format championship final (5 elimination rounds – start with 8 finalists, swim 50 fly. Remove 7th and 8th place finishers. Swim. Remove 5th and 6th place finishers. Swim. Remove 4th place finisher. Swim. Remove 3rd place finisher. Swim to determine winner) on Saturday AM.

FINAL RESULTS: Results will be sent via email as soon as possible after the meet. If a team would like a copy of the meet back-up or results immediately following the meet, they should bring a flash drive.

CONCESSIONS: A variety of delicious food will be available during the meet.

Please sit in designated areas for teams. All swimmers must keep their swim bags in the team sitting areas. All spectators must sit in approved spectator seating. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.
