Athlete will be unattached until the 120 days is determined and/or transfer is resolved. Based on the attachment date, the athlete will be listed on the SWIMS database as either unattached or attached, reflecting the new club.

The former club has the responsibility to notify the LSC registrar within sixty (60) days if the club has obtained a court judgment in accordance with [USA Swimming Rules Regulations 203.6](#). If there is a court judgment, the swimmer will be Unattached until such time as the judgment has been satisfied.
