In granting this sanction it is Understood and agreed that USA swimming and Wisconsin Swimming, Inc. shall be free from any Liabilities or claims for damages arising by reason of Injuries to anyone during the conduct of the event. USA-S deck registrations will not be accepted.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Deck Seeding: All deck seeds must be completed 30 minutes before the Start of the meet. Deck seeds will be \$5.00 per event Plus \$3.00 splash fee if swimmer is not already entered

Into the meet. Proof of USA swim registration is Required. Deck seeding of events will only be accepted If a heat contains an open lane. Additional heats will be Not be created.

No Positive Check-in will be required for the 500 free, 1000 free, or the 400 IM. Heats will be seeded fastest to slowest times. There will be a short in water break before the 500 free and also before the Sunday Long Distance Session. **Swimmers will need to provide a counter and 2 timers for the 1000 free and 400 IM.**

Warm – ups: First 20 minutes: Circle Swim Lane 1-6
Next 20 minutes: Sprints Lanes 3,4
Circle Swim Lanes 1,2,5,6
Final 20 minutes: Sprints Lanes 2,3,4,5
Circle Swim Lanes 1,6
Feet first three point entry from the starting end of the Pool will be enforced

Meet Format: Meet will be pre-seeded. All swimmers report to the Blocks prior to your event.

- Coaches:** Coaches packets can be picked up at the scorer’s table.
Any money due will need to be paid at that time.
- Awards:** Individual awards for 1st – 12th place
Relay awards for 1st – 5th place
The 500 free, 1000 free, and 400 IM will be swam as an Open event but will be awarded as 8&U, 9-10, 11-12, And 13& up.
Awards are to be picked up at the Awards table. They Will not be mailed.
- Final results:** Final results will be posted on Wisconsin Swimming Website. Additionally, each team will be emailed an electronic copy.
- Admission:** \$4.00 for ages 8 and older.
A limited number of heat sheets will be available at the Door for \$4.00. Heat sheets can be printed for free At www.teamunify.com/wiscsc.
- Seating:** Due to crowding in the pool area, we request that all Swimmers refrain from sitting in the spectator bleacher Area. **Blankets, towels, or other items will not be allowed for saving seats.**
- Concessions:** Food will be available for purchase in the high school Commons. There is no food allowed on the pool deck.

Conduct:

All coaches are responsible for the conduct of their swimmers and must see that their club has proper supervision at all times. Meet Marshals with the concurrence of the Meet Director or Meet Referee have the authority to remove any swimmer and/or spectator from the meet for any violation such as Improper behavior, damage to property, etc. No smoking on the premises. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of audio or visual recording devices, including cell phones and mp3 players, is prohibited in the locker rooms, rest rooms or changing areas. Teams, swimmers, and spectators should pick up and properly dispose of garbage. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.
