- A. Competition Pool: The RecPlex Aquatic Center is an indoor 10 lane, 50M pool, 7.5' lanes, depth of 7 feet at the start end, 12.5' at the turn end. Full-automatic Colorado timing system with full-video LED scoreboard, aquagrip touchpads and backup buttons. Pool is certified in accordance with 104.2.2C(4). A copy of the certification is on file with USA Swimming.
 - B. Warm-up/down Pool: 2 lanes in the adjacent waterpark pool will be available
 - C. Locker Rooms: accessible from the lobby and pool deck, only athletes are allowed in locker rooms.
 - D. Athlete Seating: primary athlete seating is on the pool deck as well as overflow seating in the fieldhouse.
 - E. Spectator Seating: Spectator seating is in the grandstands, elevator accessible as well as reserved disabled seating. No folding chairs are allowed in the grandstand area (stadium chair-backs are allowed)
 - F. Concessions & Vendors: concessions are available in the lobby, Elsmore swim shop will be set up with swimwear & accessories, Bella's Custom will be on-site for t-shirts and apparel.
