Payments made by check to NBSC that are not honored by the bank will incur a returned check fee of \$25. Previous season balance and first payment are due by September 13th, 2019 or we reserve the right to keep your swimmer(s) out of practice until the balance is paid.

STEP 5: NBSC Volunteer Requirement

I understand that it is MANDATORY to work FOUR (4) full sessions for our NBSC home meets. Two (2) sessions are required for Octoberfest on October 19-20, 2019 and Two (2) sessions are required for the Valentine Open on February 15-16, 2019. I understand that payment of \$400 upfront at registration is to insure that I work the required sessions. \$200 pre-dated check (10-21-19) for Octoberfest, and \$200 pre-dated check (2-17-20) for the Valentine Open. If I choose not to volunteer or do not show up for my session the check of \$200 will be cashed (on 10-21-19 and/or 2-17-20). I understand that if I work my four (4) sessions my pre-dated check(s) will be shredded or voided and returned to me per request.
