2. Masks will be required inside the pool facility for this event for all participants (coaches, athletes, officials, volunteers).

3. Location:

Howard-Suamico Community Pool
Lineville Intermediate School
2700 Lineville Road
Green Bay, WI 54313

4. Facility:

Indoor 25-yard pool with 8 lanes, non-turbulent lane markers, and backstroke flags. The pool depth is 12 feet at starting end and 3.5 at turn end. Block height is 34 inches. The 2nd and 4th leg of all 100-yard relays must start in the water from a push-start due to pool depth.

5. Timing/Judging:

All events will be timed finals. Colorado timing system with touchpads and plunger will be used. There is one manual stopwatch per lane.

6. Official Rules:

Current USA-S and Wisconsin Swimming rules shall govern the conduct of this meet. The no-recall start rule will be in effect.

7. Meet Schedule:

Saturday and Sunday:

Morning Sessions:

- Warm-ups 7:30 a.m.
- Meet begins 8:35 a.m.

Afternoon sessions:

- Warm-ups will begin after the morning session ends, not before 11 a.m.
- Meet will begin 60-minutes after the start of warm-ups.

8. Warm-ups:

Warm-up lanes and times will be assigned for each team, posted on the HSSB website, and included in coaches' packet prior to meet. Three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.

9. Eligibility:

Swimmers do not need to be registered with USA Swimming, however only registered athletes' times will be loaded into the USA Swimming's SWIMS database. Age is as of November 6, 2021. USA Swimming rules prevail for the meet.

10. Entry Deadline:

All entries must be received no later than Tuesday, 10/26/2021. Please submit entries on HyTek email.

11. Entry Limit:

Swimmers may compete in a maximum of 4 individual events per day. Relay entries do not count against the limit.

12. Entry Fees:

- Relays \$12.00

15. Awards:

Awards will consist of medals for 1st-3rd place and ribbons for 4th-16th place for individual events, and ribbons for 1st-5th place for relays. Heat winners will receive awards.

16. Spectators:

Spectators will not be allowed for this meet. The meet will be livestreamed on HSSB's YouTube channel: <https://www.youtube.com/channel/UCI9RYxwnEgnrn067TylJhhg>

Heat sheets will be available for **free** online at www.hssb-wi.org the day before the meet for all attendees to print out.

17. Coaches Note:

Coaches' packets will be available at the meet management table. If a coach is representing a USA registered club, please provide your proof that you are in good standing. If the club is not USA registered, no proof is needed.

18. Conduct:

Each club is responsible for the conduct of its swimmers. All teams please keep your area as clean as possible.

In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated area is not appropriate and is prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

MAAPP POLICY: All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. An athlete member at a sanctioned meet who is over 18 years of age, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes

will also be considered “not in good standing” and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
