| Facility | Indoor 25 yard pool with eight 7' lanes, non-turbulent lane markers, backstroke flags, 32" Paragon quick start slanted starting blocks, guttered pool. Pool depth is 12' at the starting block end and 3 1/2' at the opposite end. Finis backstroke ledges are available for backstroke events, provided the swimmer is certified. | | |
| Course | Either 6 lanes (with lane 7 closed, lane 8 for warmup/cooldown) or 8 lanes will be used for competition, as determined by the entry chair based on the number of entries. The Competition course has not been certified in accordance with 104.2.2(C). | | |
| Timing | All events will be timed using a Colorado Timing System with Strobe/Horn Start. For 25s, 2 buttons and 2 watches will be used. For 50s or more, Touch pads, one button, and 2 watches will be used. All events will be timed finals. | | |

| Entry Fee | Individual events: \$4.00; relay events: \$10.00; WI Splash Fee \$4.00 per swimmer | | |
| Entry Deadline | Clubs that were entered for the 2020 Sprint Challenge may send in entries as early as January 1 st . New Wisconsin Swimming clubs may send in entries as early as January 8 th . New out-of-LSC clubs may send in entries as early as January 15 th . Entries will be accepted in a first-come, first served fashion. If/when the meet fills, all further entries will be denied. Initial entries are due by Wednesday, January 19. Entries may be changed through Tuesday, January 25 | | |
| Entry Limit | Swimmers may swim four individual events and one relay . Meet management does reserve the right to limit heats if for some reason there are time issues. | | |
| Deck Entries | Deck entries must be able to prove their USA Swimming membership. There are no additional fees for deck-entered swimmers after the initial meet entry fees. | | |
| Official Rules | Current USA and Wisconsin Swimming Rules shall govern this meet. | | |
| Racing Start Certification | Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement | | |
| Warm-Ups | Warmup shall be twenty-five minute sessions; starts are at the discretion of the lanes. Two sessions of warmups may be used, depending on the number of entries. | | |
| Age Groups | Events will have swimmers grouped together by age, but will be split apart to single-age/single-gender categories for results. | | |
| Seeding | This is a pre-seeded meet. It is the swimmer's responsibility to be at the blocks at the start of his/her event. Deck seeding will only be used to fill heats already created. | | |
| Staging | Storm workers will help swimmers behind the blocks. | | |
| Fly-Over Starts | Fly-over starts will be used. | | |
| Awards | Ribbons will be given 1 st through 6 th in single age divisions. High point awards will be given based to 1 st place for single age in classifications below based on individual event points. | | |
| Admission | 200 tickets will be sold per session; a \$6 ticket will cover admission and 1 heat sheet. Each account will be limited to 2 tickets per session. | | |

| Meet Conduct | <p>In accordance with USA Swimming rules, NO SPECTATORS ARE ALLOWED ON THE POOL DECK. In accordance with the Federal Video Voyeurism Prevention Act of 2004 the use of camera phones or video recording devices in the locker rooms is prohibited.</p> <p>Deck changing is prohibited.</p> <p>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</p> <p>"Pursuant to Wisconsin Swimming, Inc. mandate, all applicable adults participating or associated with respective meet to which this information applies, acknowledge that they are an applicable adult, subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand the compliance with the MAAPP Policy is a condition of participation in the conduct of this competition."</p> <p>Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet. An athlete member at a sanctioned meet who is 18 years of age or older, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.</p> |
