## SPDY Fall Invitational

### MEET INFORMATION

- Dates:** Saturday, November 16<sup>th</sup> & Sunday, November 17<sup>th</sup>, 2019
- Location:** Stevens Point Area YMCA, 1000 Division Street, Stevens Point, WI 54481
- Facility:** 25 yard pool, non-turbulent lane dividers with 15 meter markers, 5'6" starting depth with 27" high starting platforms. The water temperature will be kept within a range of 79 - 81 degrees.
- Timing System:** IST timing system and IST projection scoreboard will be used. The primary timing system will consist of Aquagrip touchpads at both ends. The secondary timing system will include one semi-automatic button. The tertiary timing system will include manual stopwatches using two timers per lane.
- Scoring System:** Hy-TEK Meet Manager 7.0 scoring software will be used.
- Eligibility:** YMCA swim teams only. All swimmers must be full privilege members of the YMCA they represent.
- Rules:** The meet will be conducted in accordance with the current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP") and Regulations (Technical Rules), Rules That Govern YMCA Sports and Swimming Addendum to the Rules That Govern YMCA Sports, except where rules therein are optional and exceptions are herein stated.
- Adaptive Swimming:** Swimmers with a disability are welcome to enter this meet. At the time of entry the coach or person entering the swimmer must alert the Meet Director and Meet Referee regarding the nature of the swimmer's disability, the swimmer's classification (if classified), and requests for any special accommodations.
- Entries:** Submit entries to Eric Demrow by sending a HyTek Meet Manager entry file with text summary via email. If you are unable to send an electronic entry file please contact the Meet Director. Swimmers age is calculated as of November 16, 2019.
- Entry Limit:** Swimmers are limited to participation in 3 individual events and 1 relay per.
- Entry Deadline:** Entries must be received no later than November 11, 2019. The meet will be limited to 400 swimmers on a first-come, first-served basis.
- No deck registration will be allowed. Deck entries will be taken at the discretion of the Meet Referee or designee as long as they do not result in any additional heats. The cost for deck entries is 2 times the normal entry fee. The deadline for deck changes and/or deck entries is 30 minutes before the scheduled start of each session.
- Entry Fees:** \$4.50 per individual event and \$14.00 per relay. Checks should be made payable to the "Stevens Point Area YMCA". Entry fee checks and waivers may be brought to the meet.
- Awards:** **Individual Events:** Medals 1<sup>st</sup>-3<sup>rd</sup>, Ribbons 4<sup>th</sup>-12<sup>th</sup>. **Relay Events:** Ribbons 1<sup>st</sup>-6<sup>th</sup>.  
Awards will be grouped by team and sent with the coaches at the conclusion of the meet. High Point Trophies will be offered to the top three male and female swimmers in each age group.
- Scoring:** Points will be awarded to the top 16 finishers in each event as follows:  
**Individual** - 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1  
**Relays** - 40-34-32-30-28-26-24-22-16-14-12-10-8-6-4-2
- Admission:** Heat sheets cost \$4.
- Conduct:** All teams will be responsible for the conduct of their own swimmers. The Meet Directors have the authority to disqualify swimmers found misbehaving.

### Warm-ups:

Warm-up assignments will be given out after all entries are collected. Lanes will be assigned based on final entry numbers.

### Dressing Rooms:

Dressing rooms have limited lockers. Swimmers are responsible for securing their own belongings. The Stevens Point YMCA is not responsible for lost items. There will be a lost and found located at the YMCA front desk. In accordance with the Federal Video Voyeurism Prevention Act of 2004, the use of camera phones or video recording devices in the locker rooms is prohibited.

### Rest Area:

A rest area will be offered in the YMCA Gymnasium.

### Swimming Shop:

Dive Point Scuba & Adventure will be selling swim suits, goggles, swim caps and other assorted swimming equipment near concessions.

### Staging:

Seeding will be provided for the 8 & Under and 9 & 10 age groups.
