The Walter Schroeder Aquatic Center is located north of Brown Deer Road (Hwy 100) and east of Green Bay Road (Hwy 57) on Schroeder Drive.

FACILITY: Indoor, 50-meter pool, non-turbulent 6-1/2 foot -17 foot depth and 7 foot wide lanes. A mix of SST & Colorado Timing equipment will be used. One back up button and one watch per timer will be used. Backstroke wedges are available if the athlete chooses. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

GENERAL: In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

In applying for this sanction(ed event), the Host, Waukesha Express Swim Team agrees to comply and to enforce all health and safety mandates and guidelines of USA Swimming, Wisconsin Swimming, Inc., the State of Wisconsin and the North Shore Health Department.

We have taken enhanced health and safety measures for you, the other participants, and meet staff. You must follow all instructions while visiting Waukesha South High School. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable.

USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease. Therefore, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or

increasing your risk of contracting or spreading COVID-19.

The Waukesha Express Swim Team will follow safety protocols set by the North Shore Health Department, Walter Schroeder Aquatic Center, Wisconsin Swimming and USA Swimming. A few key notes:

- Masks are required for everyone in the facility and social distancing is a must.
- Athletes will be screened as they enter with temperature checks, and wellness questions.
- Spectators will not be allowed in the facility.
- Locker rooms are not available, swimmers should arrive in their competition suit. Athletes, Coaches, Meet Personnel and Family members may use the restrooms one at a time per gender and must wipe down all touched surfaces and put the toilet seat back up after use to indicate that it has been cleaned.
- Meet workers will be kept to a minimum. Positions will be first offered to Waukesha Express Swim Team parents, then offered to parents of other teams as available.
- No one should enter the facility if he/she has any symptoms of COVID 19.
- Sessions will allow a maximum of 185 swimmers per session.
- No concessions will be provided. Plan accordingly.
- The deck will be cleared before allowing the next group of swimmers in the facility.
- Starters will use electronic command whistles.
- Meet volunteers will be limited and will be held to all of the above guidelines.
- This list is not all inclusive. Anyone that does not abide by all rules above or further instructions given by coaches or meet marshall's on site, will be asked to leave. No refund of entry fees will be provided.

ENTRIES:

This meet will be run using the HY-TEK MEET MANAGER. Export a meet entry file and email it as an attachment. Upon completion of the meet, results, a results file and a MM Backup file will be posted on our website. Please send a .pdf of your entry with your entry summary. Hand carry a check for entry fees. No deck entries will be accepted.

All non-Wisconsin Swimming registered group members (teams) and athletes (including UN athletes outside of the WI LSC) wishing to participate within Wisconsin's LSC must obtain written approval from their respective LSC and forward it to meets@wisconsinswimming.org before participating within Wisconsin's LSC.

Meet hosts should not allow entries unless the requisite approval from the club/athletes home LSC is on file with the Wisconsin Swimming office. Times achieved by non-Wisconsin athletes where the home LSC did not approve of the athletes travel to the Wisconsin LSC Territory will not be loaded into SWIMS.

Facility surcharge: \$12.00

WI LSC Surcharge: \$4.00

Individual events: \$8.00

TIME STANDARDS

No time standards. Swimmers with state cuts can compete in any/all races.

SESSION INFORMATION

Saturday and Sunday: Sessions may be adjusted as needed to meet facility COVID-19 guidelines. Up to three sessions per day.

All events are timed final events.

WAIVER:

Adult Athlete or Parent/Guardian of a minor must complete the included waiver. Coaches will be responsible for submitting all waivers for their team at check-in.

OFFICIAL RULES:

Current USA and Wisconsin Rules shall prevail for this meet. Swimmers must be current USA Swimming members.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Further, those participants not proficient with a backstroke ledge must start each race from within the water, and without use of the backstroke ledge.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

Deck changes are prohibited.

MAAPP POLICY: Pursuant to Wisconsin Swimming, Inc. mandate, all applicable adults participating or associated with respective meet to which this information applies, acknowledge that they are an applicable adult, subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand the compliance with the MAAPP Policy is a condition of participation in the conduct of this competition. Effective 11/6/2019 times achieved by an athlete member at a sanctioned meet who is over 18 years of age (+30 day grace period) who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to the SWIMS.
