- Location: Waunakee HS Pool, 100 School Dr., Waunakee, WI 53597
- General Information: In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
- Facility: Eight lanes, 25 yards flush deck, non-turbulence lane dividers and backstroke flags, with 18" height starting blocks. Pool is 7.5 feet deep at the starting blocks and 3.5 feet deep at the non starting end of the pool.  
**The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2(c).**
- Timing: **100 yard relays will have the 2<sup>nd</sup> and 4<sup>th</sup> leg of the relay start in the water.**  
Colorado System 6 with backup watches. All events are timed finals.  
Computerized score board for all lanes.

- Rules: There will be at least four certified USA Swimming Officials on deck at all times.  
Current USA Swimming and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA Swimming. Events/heats may be combined as directed by the Meet Referee during the meet and by Meet Director for pre-meet seeding. 500 Free entries may be limited to stay within appropriate time frame as directed by Meet Referee. Additional breaks may be added if need is determined by Meet Referee.
- Check-ins: 12 and Under 500 Free will be a positive check-in event. Check in with the clerk of course at the timing table. Check-in will close 30 minutes prior to the beginning of the meet.
- Warm-ups: Warm ups for the meet start at 4:30pm. Meet will begin at 5:20pm.  
All lanes open for circle swim for the first 40 minutes; sprint lanes open for 5 minutes in 6 lanes, with 2 lanes remaining open for circle swim. Team lane assignments will be available in the coaches' packets.  
"THREE POINT ENTRY" ONLY. Meet Director/Marshals will be on deck during the entire warm-up, with the authority to recommend disqualification.

**Deadline:** Emailed **Hy-Tek Entries are due Monday, July 1st by 6pm.** You will receive an e-mail confirmation of your entry within 48 hours. If you have not received that confirmation, please contact the meet director via email or phone.

Entries may be limited by the Meet Director to adhere to USA-S's Rule 205.3.1(F), i.e. the four hour session rule for 12 & Under athletes. A meet timeline and psych sheet will be sent to the email address who submitted the entries prior to the meet.

Please notify the meet director and meet referee for any special requirements for disabled swimmers on the entry form.

**Entry Fees:** \$3.00 LSC splash fee per swimmer, \$5.00 per individual event, and \$12.00 per relay.

**Admissions:** 11 and older: \$5.00 per session  
10 and younger: Free

Heat sheets will be made available electronically for free prior to the meet.

**Deck USAS Registration:** WAUN will not accept deck USAS registration. An unregistered swimmer may not compete.

**Age Groups:** 8 and Under, 9-10, 11-12  
Age as of the first day of the meet.

**Awards & Scoring:** Individual Events, places 1<sup>st</sup> thru 16<sup>th</sup>: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1.

Relay Events, places 1<sup>st</sup> thru 8<sup>th</sup>: 40, 34, 32, 30, 28, 26, 24, 22, 18, 17, 12, 10, 8, 6, 4, 2.

Awards for relay events will consist of ribbons for 1<sup>st</sup>-8<sup>th</sup> place. Awards for individual events will consist of ribbons for 1<sup>st</sup>-16<sup>th</sup> place. Coaches will be permitted to pick up awards at the end of each session. Awards will not be mailed.

- Coaches:** All coaches can pick up their coaches packets at the timing table on the pool deck. **Any monies still owed must be paid before you can obtain your packet.** Please be prepared to show your current USAS Coaches membership card at the time you pick up your team packet. **Coaches' USAS membership cards must be visible at all times on deck.** Entry changes are due in writing to the Clerk of Course/Meet Director at the timing table on the pool deck 30 minutes prior to the start of each session.
- Admissions:** No Admission fee, but there will be a \$5.00 facility fee charged per swimmer
- Concessions:** Heat sheets will be available electronically for free prior to meet. A large selection of hot and cold food and drinks will be available throughout the session.
- Meet Conduct:** Flyover starts will be used. All teams are responsible for the conduct of their swimmers. The Meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner. In accordance with the Federal Video Voyeurism Prevention Act of 2004 - the use of camera phones or video recording devices in the locker rooms is prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.  
[Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.](#) Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.
