Athlete Registration Packet and General Information:

TO ALL QUALIFIED SNAKE RIVER SWIMMERS and PARENTS

- This meet is open to all 19 and under Snake River Swimming Athletes who have achieved a Senior Zone Qualifying time between 2/1/2018 and 7/29/2019 (Note swimmers who have achieved a Summer Junior National Time standard cannot compete in that event!)
- Snake River swimmers from the entire LSC will swim together as one team.
- Swimmers will receive a \$200 subsidy from SRS

Location:

- Clovis, California. The meet is held in two different pools. We will rotate each location throughout the competition. Pool Schedule TBA.
 - Clovis North Aquatics Complex – 2770 E. International Ave.
 - Clovis West Aquatics complex – 1070 E. Teague

Travel and Hotel:

- All travel, lodging, and food while in Clovis are up to each individual family.
- Snake River does have a block of rooms set up for swimmers and families at the Country Inn & Suites By Radisson, Fresno North –6065 N. Thesta Avenue Fresno, CA 93710
- Each family is responsible for booking their own room by June 17

Entries:

- **Individual club coaches will be responsible for submitting all meet entries and fees on OME.**
 - Individual events - \$9.50
 - Relay events - \$18.50 (this will be decided after all entries have been finalized.)
 - Swimmers can compete in up to 7 individual events throughout the meet.
 - Bonus events- If you have achieved one qualifying time for the meet you are eligible to swim BONUS events in which the Bonus standard has been achieved. These are for events 200 m or shorter.
 - **Entries are Due on OME by July 22rd @ 11:59**

- Tuesday July 30 (m/w 1500 free)
- We will have a team warm up Tuesday afternoon for all swimmers not in the distance free events (Time TBA)
- We will have a Snake River Swimming Team dinner on Tuesday evening after the warm up!
- Regular competition will be held from Wednesday July 31 – Saturday August 3

Athlete Code of Conduct

PURPOSE: The purpose of this document is to ensure that all Snake River Zone Team athlete and non-athlete members conduct themselves in a manner which reflects honorably on the sport of swimming, USA Swimming and Snake River. Each SRS Zone Team athlete and non-athlete is required to comply with this Code of Conduct and Team Travel Policy. This form is valid for one year from the date it is signed. Violations are subject to the defined penalties per USA Swimming Rules and Regulations, Appendix D, Paragraph 4.

Mini-CODE OF CONDUCT:

“RESPECT” Myself, My Team, Zone Team Staff, Chaperones, Fellow Competitors, and Officials.

- I will maintain Courteous and Positive Behavior at all times.
- I will attend all team functions including meetings, practices, meals, meet sessions, etc., unless otherwise excused or instructed by the head coach or his/her designee.
- I will not engage in any Fighting or Disorderly Conduct.
- I will not participate in any Vandalism or Damage to private or public property
- I will not participate in any Theft, “Borrowing”, or “Souvenir Taking” of any type.
- I will not be in possession of or participate in the use of any Tobacco Products, participate in the consumption of Alcohol Beverages, or participate in the consumption of any NonPrescription Drugs. (Excluding medications prescribed for the individual with written note provide to team manager by parent in advance of meet.
- I will abide by any other Rules as established by the Zone Team Staff as needed. **PENALTIES:** Any or All of the following penalties may be considered and imposed according to the severity of the infraction:
 - Excused from the Meet and sent home at the “athlete parent’s expense” (Parents shall also pay for a Chaperone to accompany the swimmer home if needed.)
 - Forfeit of all Team supplied apparel or other articles/items.
 - Forfeit of SRS financial travel allocations.
 - Restitution of damages.
- Formal written apology to offended parties. This serves as notice of penalties per USA Swimming Rules and Regulations, Appendix D, Paragraph 4. Please be informed of your rights under the USA Swimming Rules.
