Minutes from the HOD meeting November 12, 2018 were presented for approval. Minutes had been previously been both emailed to HOD members and posted on the WYSI website. Clint moved to accept the minutes. Jennifer seconded the motion. Vote held and motion passed.

Winter State Bid:

Three teams had submitted bids for Winter State: Laramie, SWAT, and Gillette. A representative from each team spoke, promoting their facility and outlining their proposal to host Winter Championships. Additionally, the Gillette head coach, Holly Campbell, reported on the status of the Gillette Pool regarding leaking of the gutters and ongoing repairs. The Gillette pool is to be fully repaired and ready for practice and competition in 1 ½ weeks.

A vote by ballot was held. Laramie received 14 votes, Gillette had 5 votes, and SWAT received 9 votes. Laramie won the vote and will host Winter Championships in March, 2020. Summer Championships will be held in Gillette, WY.
