#### Bank Draft Authorization/Credit Card Electronic Fund Transfer Authorization:

Member's Initial	3) Should any deduction not honored by my bank for any reason, I realize that I am still responsible for payment, plus a service charge of no more than \$30.00 applied by the Y. This is in addition to any service fee my bank may make. I understand that it is my responsibility to notify the Y in writing should I change my financial institution and/or account at any time.
